## WHAT DOES FOSTER BLUE WATER OIL LLC DO WITH YOUR PERSONAL INFORMATION?

**Why?** Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

**What?** The types of personal information we collect and share depend upon the product or service you have with us. This information can include:

- Social Security number and income
- Account balances and payment history
- Credit history and employment information

**How?** All financial institutions need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons FBW/Blue Flame chooses to share; and whether you can limit this sharing.

**Who we are**

**Who is providing this notice?**

Foster Blue Water Oil LLC and affiliates Blue Flame Propane Inc., and Blue Water Oil Transport LLC, include petroleum companies, a propane company and a fuel transport company.

**What we do**

**How does Foster Blue Water Oil protect my financial information?**

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

**How does Foster Blue Water Oil collect my personal information?**

We collect your personal information, for example, when you

- Open an account
- Pay your bills

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

**Why can't I limit all sharing?**

Federal law gives you the right to limit only

- Sharing for affiliates' everyday business purposes – information about your creditworthiness
- Affiliates from using your information to market to you
- Sharing for nonaffiliated companies to market to you

State laws and individual companies may give you additional rights to limit sharing.

**What happens when I limit sharing for an account I hold jointly with someone else?**

Your choices will apply to everyone on your account.

**Definitions**

**Affiliates**

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- Our affiliates include: companies with a common corporate identity of Foster Blue Water Oil LLC, Blue Water Oil Transport LLC, Blue Flame Propane Inc., and My Choice Energy.

**Nonaffiliated**

Companies not related by common ownership or control. They can be financial or nonfinancial companies.

- Foster Blue Water Oil LLC does not share with nonaffiliated companies so they can market to you.

**Joint marketing**

A formal agreement between nonaffiliated financial companies that together market financial products and services to you.

- F does not jointly market.
